Over the year this has been signalled and reinforced with an excellent programme of lectures with first-class international speakers.

The ever popular Corporate Partners briefings have been filled to capacity demonstrating the Society's ability to attract the leading figures from industry and government.

It is good to see so much enthusiasm for our second Annual Conference in April which again has been made possible by the help of our sponsors.

Chief Executive's report, Keith Mans



During the year, we continued to raise money for our library project and, while we were disappointed about the Heritage Lottery Fund turning down our initial bid for assistance, I am pleased to say that we are still in discussion with them and I still hold out the hope that we will be successful in the end.

Once again 2005 was a very busy year for the Society in general and all the staff here at 4 Hamilton Place in particular.

Our first Annual Conference for a considerable time took place in April and was a huge success. During the three days over 500 people attended from right across the aerospace community.

We were very grateful to all our sponsors for the huge amount of support they gave us and we are very much looking forward to the 2006 Conference which takes place on 4, 5 and 6 April, and already looks as if it will be even more successful.

Throughout 2005 the Conference programme worked well with a revamped department and a focus on marketing. This was not only evident from the increased numbers of people that attended our conferences but also the attendances at named lectures. Five years ago some of our named lectures were attracting fewer than 50 people, whereas in the past year none of them has attracted fewer than 100, and in some cases a lot more than that. I am certain this is partly because of the continued increase in membership of the Society which I will not dwell on this year, having covered in considerable detail in the February edition of *The Aerospace Professional*.

Alongside fund raising, we also moved the majority of our archive out of the basement into secure, damp-proof accommodation, provided for us by BAE Systems at no cost. This released space in the basement which is being converted into a Business Suite for use by members and employees of Corporate Partners — the latter paying a small daily charge, whereas for the former the use will be free. The completion of this Suite — the Airbus Business Suite, should be taking place as you read this review. It has been made possible only because of a generous donation by Airbus. I am sure it is going to be very popular with our members and our Corporate Partners.

We also decided in 2005 to carry out a major revamp of our website and again this is about to get under way.

Alongside these changes in what we have done, we have also had some staff changes. We said goodbye to our finance manager, Tony McManus, and our former conference manager, Christine Philbin. In the case of Christine, she has spent 2005 mainly working on the library project and strictly

At the beginning of the year we welcomed Sarah Moore, our new professional standards manager and in July, Tony Homes, our new finance manager, arrived. Deborah Hartwell also joined us during the year to work alongside Annabel Hallam as admissions officer — Annabel having returned to work following the birth of her son. Emma Bossom joined the Conference and Events Department and Tanwa Idris replaces Shumi in the Careers Department.

Prof Keith Hayward, our

first head of research, joined us at the beginning of 2005 as did Gareth Halstead and Aggi Bailey, both the latter working in Venue Services, the former as an assistant replacing Robert Lee and the latter as manager replacing Laetitia Laurent.

I should not forget the steady stream of excellent Rolls-Royce graduate trainees that have been with us during 2005 and a big thank you to Brenda Gallagher, Celene Roche, Angus Macdonald and James Matthews for their contribution.

Some time ago we thought it would be a good idea to have a staff photograph as it turns out this has not been done in living memory, so what better way than to end my review in 2005 with a photograph (opposite) of my staff who have worked hard and made a huge contribution to a successful 2005 for the Society.

Unrestricted Funds also include funds of Aeronautical Trading Ltd that the Society may spend without attached conditions, subject, of course, to proper Council approval. All other funds are from bequests for specific purposes held by the Society in accordance with trusts established by the donor.

Finance Board

The Finance Board is responsible for the planning and oversight of all financial

matters. These include the long-term strategy for reserve funds and capital assets, the annual operating budget and capital expenditure plan, and the maintenance of internal financial controls and safeguards, and for awards made by the Education and the Medals and Awards Committees.

Highlights

- The operating profit was £46,224;
- Overall the results for the year were good. However, it should be noted that the

operating surplus has been reduced to reflect the adjustments required under SORP/FRS17 to account for the Defined Benefit Pension Scheme for the first time in 2005;

- 2004 accounts have been restated to reflect current accounting policies;
- Membership income is up by 3.2%;
- Corporate Partners income increased by 17.2% on last year after eliminating differences caused by a change in basis;
- External room hire and associated income is up by 24%;
- Overheads rose by 14.1% mostly in the room hire area which was in line with the increased income;
- Publication revenues fell by 16%. However, with a new advertisement agent taking over in 2006 it is hoped that revenues will increase in future years;
- The Balance Sheet has been adjusted to reflect new accounting policies under FRS17 on accounting for the Defined Benefit Pension Scheme. Even though the

- In 2005 the year the Society appointed new investment advisers, Rensburg Sheppards Investments Management Ltd (formerly Carr Sheppards Crosthwaite). Their remit was to move the Society's cash based deposits to a

wider spectrum of investments to achieve greater long-term capital growth. During the year the Society invested a further £1.4m and by the end of the year the Society's total investments had gained £265k to stand at £2.3m. The Society investment strategy will be reviewed in 2006;

The RAeS Paris Branch hosted a champagne breakfast during the Paris Air Show. The event on 16 June took place at the SIAE chalet (Salons Internationaux de l'Aéronautique et de l'Espace — the Paris Airshow organisers) courtesy of the Commissaire Général of the Show, M. Louis Le Portz, FRAeS.

and diversity of the aerospace community in Hamburg with numerous organisations and no fewer than 11 different nationalities represented at the event.




Membership

Society membership at the end of 2005 was 19,343. This compares with 19,166 at the end of December 2004.

The Society had a presence during the year at a number of air shows (Pilot Training Exhibition, Old Warden, RAF Cosford, RN Day at FAA Yeovilton, RIAT) as well as in-house conferences at Hamilton Place. Attendance at Careers events and the activities of the Young Members Board all helped to boost membership applications.

Existing members were encouraged to consider if their membership grade was appropriate to their current aerospace experience and for those who are engineers to seek formal recognition by applying for registration as Engineering Technicians, Incorporated Engineers and Chartered Engineers. A significant number of existing members have taken the opportunity to reassess their membership eligibility. If you have not yet looked at this aspect of your membership, contact the Membership Department, who will be pleased to provide further information.

As part of a review of membership costs and benefits we contacted some 3,500 members via e-mail with a questionnaire. The response was dramatic and rapid with over 300 responses in 48 hours. We will take forward suggestions we received but please be sure we have your e-mail address to help improve our communication with you.

Corporate Partners

The number of Corporate Partners at the end of 2005 stood at 120 (the figure was 119 for the end of 2004).

The Corporate Partner Seminar marked the start of the programme of corporate partner events for 2005. Speakers at this Seminar examined the prospects of the aerospace community for 2005 by focusing on the major projects and the underpinning financial position of the industry.

Following the Seminar, the Society delivered a programme of seven briefings over the year. Attendance at the briefings is exclusive to staff at Corporate Partner companies/organisations. Our guest speakers for 2005 were The Lord Garden, Martin Broughton, Iain Gray, Sir Digby Jones, Patrick Goudou, The Rt Hon Alun Michael, MP, and Dick Olver.

To date we have scheduled six Corporate Partner briefings for 2006 and these will be given by Karen Buck, MP, Sir Brian Bender, Professor Sir Gareth Roberts, Geoff Muirhead, Paul Barron and Professor Roy Anderson.

At the beginning of the year we sampled some 20 of our Corporate partners and found that they all valued the high level briefings most of all. To improve our communication with them Beverley Gaynor will take on the management of the scheme on a full time basis.

Two changes that have had a significant effect on the work of the Learned Society Board (LSB) were introduced at the start of 2005. The first was the restructuring of the Board into a smaller, more business focused body with a larger sub-committee, the Specialist Group Committee (SGC), to oversee the day-to-day activities of the Specialist Groups. The second was the successful merger of the Conferences, Corporate Events and Venue Services departments. There was also a change of chairman as Sir Colin Terry stood down as he approached the start of his Presidential year.

The 'new' LSB is much smaller than the 'old' one, with seven members (plus the chief executive) who bring with them their expertise in specific areas for which the Board has oversight responsibility, as well as their general contribution to the work of the LSB throughout the year.

Conferences and Events

2005 has been a successful year for the Society's conference and events programme. It would not be possible to hold such events without the hard work of the volunteer members of the Specialist Groups and other committees whose specialist knowledge ensures the relevance of the content and the suitability of the speakers, as well as identifying possible sponsors. At the same time, the event could not take place without the professional expertise of the Society's Conference, Events and Venue Services team. Both sides in this

partnership are consistently praised in the feedback received from conference delegates for maintaining the high standard for which Society events have a justifiable reputation.

In 2005 some 4,951 people attended RAeS events held at Hamilton Place — 33 lectures and briefings, and 28 conferences and evening events. This included the first, and very successful, Annual Conference in April. In financial terms, a challenging budget target was achieved. We would like to acknowledge, and record our thanks to those individuals and companies that have given sponsorship support for a wide range of events throughout the year.

Publications

There had been concern in recent years about the reducing number of papers being submitted for publication in the *The Aeronautical Journal*. This year has seen a closer relationship established between the Specialist Groups and the editors of the *Journal* and as a result the situation has improved considerably. There have been some changes to the design of the front covers of *The Aeronautical Journal* and *The Aerospace Professional*. Advertising for the three journals was put out to tender and new agents selected and from 1 March 2006 McMillan-Scott will be the sole advertisement agents.

Library and Archive

This year has seen the removal of the archive material that

was formerly kept in the basement, to a better location and work progresses to establish the National Aerospace Library. The Society's collection will be at its core, with the library at Hamilton Place as a prominent component. Fund-raising for the project started towards the end of 2005 and members will have seen the invitation to make a contribution to the library fund in the December copy of *The Aerospace Professional*. More details can be obtained from the chief executive.

Website

The LSB started 2005 with a fundamental review of the website in response to consultations with individuals and groups of members. We

needed to understand what we were intending to achieve by having a website; how was it working; how could it work better to support the Society's activities and what value should it be able to add to the service given to members and the interest shown by visitors? The year 2005 proved to be another demanding but successful year for the Young Members' Board (YMB). Over the course of the year the YMB has organised two successful conferences, assisted in organising the Ballantyne lecture, given a large number of roadshow presentations as well as representing the views of the younger members at all levels within the Society.

The Board is composed of 20-25 young members from across the aerospace industry. Without these volunteers and the support that they receive from their institutions and companies it would not be possible to maintain the activities of the YMB. If you interested in getting involved with the Board or know of someone who may be then please contact us at youngmembers@raes.org.uk. In particular, greater representation by student members of the society would be welcomed.

Events

The first YMB event of 2005 was the Annual Conference, entitled 'Does size matter?'. The conference asked whether size matters for the future development of the aerospace industry, particularly focusing on the A380, airport development and the future for careers in the industry. The presentation by Mike Toms of BAA was particularly timely as it coincided with the High Court ruling on future airport development at Stansted, adding some extra excitement to the day.

In March the YMB supported

the careers and conference departments in the running of the Ballantyne lecture. This proved to be another successful event, attended by 123 young people and their teachers. The day, entitled, 'Aerospace engineering: invention and innovation', looked at the variety of ways in which aerospace careers allow for innovative thinking and how young people could get involved. The speakers included the Chief of Air Cadets, a former YINI placement student and representatives from Microturbo and QinetiQ.

The 2005 roadshow season ran from September to November with more than 20 institutions visited by YMB members and society staff. The planning for the roadshow presentations represents a substantial logistical exercise for the Board. This year's roadshow season was deemed to be a success with in excess of 1,000 undergraduate students receiving the presentation and the Society receiving a substantial number of applications as a consequence.

Ordinarily, the final event of the YMB calendar is AeroChallenge. However, early in the year the Board decided to swap the dates of the Annual Conference and AeroChallenge. As a consequence, the second Annual Conference of the year took place in November. The theme of the conference, entitled 'A life worth living', was the lifecycle of aerospace systems. A number of high quality speakers from all sectors of the industry spoke about product conception,

development, launch, in-service support and disposal. In addition, in parallel with the conference presentations, the careers department ran careers advice sessions throughout the day. The event was a great success and was attended by over 130 young members.

Communications

The YMB has a number of electronic communications methods including the website, the e-group and YMSList. The YMB also has a monthly column in *The Aerospace Professional*. Articles are always welcome for this column. If you are interested in expressing an opinion or writing about something of interest to other young members, contact youngmembers@raes.org.uk.

In March the YMSList e-mail service was re-launched with a new streamlined, graphical look. The monthly e-newsletter aims to promote events and opportunities of interest to the young members of the society. To receive YMSList send an e-mail to ymslist@raes.org.uk with 'add ymslist' in the subject line.

In October the YMB web-pages were reviewed and substantially updated as a precursor to the major society web page update. The pages contain the latest information of interest to young members.

The electronic discussion group has seen an increase in members and we would encourage people to use this tool as a means of discussing topics which are of interest to them. Members can sign up to the e-

group by going to <http://groups.yahoo.com/group/raesym> or you can e-mail raesym-subscribe@yahoogroups.com. As the Society has Divisions and Branches across the world, it is worth remembering that, when you subscribe to this discussion group, you are reaching a global audience.

Careers

During 2005 the Careers Centre continued to act as the key contact point for aerospace and aviation careers enquiries for individuals and organisations in the UK and overseas, with around 1,000 requests for information such as our job profile leaflets, aerospace-related course listings and company listings. New literature introduced included a guide to useful aerospace websites for job hunters, a UK aircraft maintenance company listing, aptitude testing links and an interview preparation guide.

The 1-2-1 guidance service received a particularly good take-up with around 125 individual appointments in 2005 of which around 60 used the service for the first time. Most users were members of the Society, particularly current students and recent graduates but others included experienced professionals and non-members.

Our strong relationship with *The Independent* continued, working closely with its team on the careers magazine *Everything Aerospace* which featured many RAeS members. We extended the relationship by collaborating on the London Air Show and RIAT events and on the new version of the professional paper, 'So you want to be a pilot', written by the RAeS Flight Operations Group in association with GAPAN. These new arrangements mean the document is now available as a free publication to the public with over 20,000 copies printed.

To conclude, we hope to build upon the successes of 2005 and make 2006 an even better year. The YMB will continue to represent the views of young members across the Society and ensure that their voice is not lost within the Society.

The EC^{UK} registration audit cycle

With the end of 2005 so too passes the mid-point in the five-year cycle associated with the Society's EC^{UK} Registration licence. The last formal EC^{UK} audit of the Society's CEng, IEng and EngTech processes and procedures took place in November 2002. The next is due in late 2007. The EC^{UK} Audit Panel adopted a 'light touch' approach in 2002. Since then the Society's excellent Professional Standards' staff and members of the PSB and its supporting community of volunteers have invested a very substantial amount of work in developing, continuously improving and auditing relevant policy and procedures documentation and practice.

That I can only now happily report closure in June 2005 on the schedule requirements arising from the 2002 audit attests both to the rigour of these processes and the professionalism and commitment of all those involved. During the second half of 2005 the PSB has already begun to focus attention on preparations for the 2007 audit. Our own internal audit programme for 2006 is a key element in these preparations. It has therefore been a considerable relief to see that the exemplary standard of leadership and professionalism set by AVM Peter Henderson in leading our internal audit team is to continue now AVM David

Couzens has taken on the task.

Tomlinson Report

During 2005 the PSB has continued closely to monitor the Tomlinson Report on educational reform and the ensuing Government White Paper '14-19 Education and Skills'. In advising Council on the issue the Board has taken the view that the Government response in the form of the White Paper had moved the debate forward inclusive of the issue of the vocational versus academic divide. The Board will be monitoring any further developments in this area.

Mutual Exemption Agreement

In May 2005 the Society and the Institution of Engineers Australia signed a Mutual Exemption Agreement offering reciprocal recognition for membership and facilitation of registration as a competent practitioner. December saw the first MRAeS/CEng registration via this agreement. The Australia Division expects to see more applications being submitted by this route and Professional Standards staff will monitor any significant increase in applications.

Professional Review interviewer training

A condition of the EC^{UK} audit in 2002 was that all Professional Review interviewers must be UK-SPEC trained. Accordingly, in May,

Peter Richards and Peter Collier facilitated a training session for experienced interviewers who had not received training under UK-SPEC. This resulted in a 50% increase in the Society's pool of trained interviewers. This significant increase in interviewers has benefited the Society in terms of having more people available to conduct interviews and has also eased the burden on interviewers.

Policy and Procedures Manual

Work was started in 2005 and will continue during 2006 to ensure that the Policy and Procedures Manual is fully UK-SPEC compliant by the end of 2006.

More on EC^{UK}...

30 September saw the closure of the Senior Route to CEng and IEng. The Society received its last applications via this route in July and successfully processed seven candidates who were interviewed in September and were subsequently registered by EC^{UK}.

The Society advertised the ETB Registrants' Panel Elections in *The Aerospace Professional* in early 2005. This was the first fully electronic Panel election. Turn-out was disappointingly low, resulting in concerns to learn lessons that would enable the community to become more fully engaged in the electoral process in future. The PSB reviewed the way in which the Society had sought

to inform Registrants of election details both through the web-site and *The Aerospace Professional*. Action is to be taken as a result to offer the 2006 Registrant's Panel election, which will take place 1-29 March 2006 (again electronically), a higher profile. All Registrants who are members of the Society will be encouraged to participate (for more details see www.etechb.co.uk/registrants or via www.aerosociety.com).

Chartered Scientist

Further to the Society being issued with a licence to award Chartered Scientist registration from The Science Council, 2005 has seen the first registrations under this licence. Additional work was undertaken during the year to improve the application pack and guidance given to candidates. The Society will be actively promoting CSci to its membership in 2006.

Continuous improvement

All the above issues have contributed to the process of continuous improvement across the PSB and its committees. As in 2004, committee succession planning has been a major focus and I am pleased to say that we have seen a steady increase in new members. At its meeting on 17 October, the Professional Standards Board agreed that the PSB and its sub-committees would instigate a three-year review period for membership based on auditable attendance

and value inputs.

On the Professional Standards Board itself, we have welcomed Howard Leach, Lloyd Dingle and Richard Blockley.

On the Corporate Grading Committee we have welcomed Franklin Spencer as the new EC^{UK} representative. The Committee continues to monitor its succession planning issues and is looking to recruit one or two new members during 2006.

On the Non-Corporate Grading Committee we have welcomed Major Ian Cooper from REME and Lt Steven Gilmore RN from the MoD.

On the Corporate Accreditation Committee we have welcomed Bill Brookes as the new EC^{UK} representative.

On the Non-Corporate Accreditation Committee, new members are Wg Cdr Gethin Hill and Ray Flower, the latter from KLM Engineering. In January, Lloyd Dingle succeeded Peter Collier as Chairman. Peter contributed significantly to the success of the Committee and to the Society in general over many years. He remained a valued member of the NCAC throughout 2005, retiring at the end of the year. I know you will all join me in wishing Peter a very happy retirement.

On the Licensed Engineers' Committee, Howard Leach succeeded Ron Forrester as Chairman. Ron has been an exceptional ambassador for aircraft maintenance and, in particular, for Licensed Engineers, and I am delighted that he wishes to remain a member of the LEC.

The Professional Standards Department welcomed the return of Annabel Hallam in July, following her maternity leave. Annabel returned in a part-time capacity and has been re-titled Grading Officer. In November 2005, Deborah Hartwell was appointed to the part-time post of Admissions Officer. The original full-time post of Admissions Officer has been divided so that Deborah deals with applications and enquiries, and Annabel is responsible for the Grading Committees and Professional Review Interviews. As the year ends Sarah Moore looks back on an exceptionally successful first year as the Society's Professional Standards Manager. Sarah took over from Paul Bailey almost exactly a year ago, settling down seamlessly into her new role. She is to be congratulated on her highly valued contribution to the work of the PSB team.

Continuing to increase the breadth and diversity of the

Professional Standards team is at the core of our continuous improvement effort. 2006 will see the Board continue to monitor the Government's White Paper on educational reform. In connection with this and developments in relation to the Bologna Declaration and the National Qualifications Framework, the Board is planning to hold a seminar to discuss grading and vocational qualifications at the earliest possible opportunity.

The Board is also considering the possibility of holding a Professional Standards conference, possibly in Q4 2006. Expressions of interest to Sarah Moore would be welcome.

Thanks and valedictory

I would like, as in previous Reviews, to thank all those

who have contributed to the work of the Board and its Committees during 2005. Particular thanks and best wishes are due to those who have stood down during the year.

Changes to PSB sub-committee membership have already been noted above or are in prospect. In every case both thanks and appreciations are due to the departing members who have given freely of their time and commitment. I welcome their successors.

On a personal note, 2006 will find me 'time expired' as a member of Council. I must therefore stand down both from Council and my chairmanship of the PSB. The experience of leading for the Society on Professional Standards has been both challenging and rewarding. It has also been a privilege to be associated with an aspect of the Society's work that exemplifies all that is best in terms of the standards and integrity of the engineering profession in aerospace. My thanks to all those who have given so freely of their advice, support, wise counsel and friendship.

Help us create the UK's first National Aerospace Library



What?

Despite the UK's prominent role in the development of aerospace over the past 150 years, we have no national archive. The Royal Aeronautical Society (RAeS), the world's oldest and most respected aerospace society, plans to establish a National Aerospace Library (NAL) and archive, using, as its core, the existing RAeS library already regarded as one of the world's foremost aerospace collections.

Where?

It is proposed that the NAL will be located at Farnborough, ideally in the Grade 1 listed historic 24ft wind-tunnel complex in the Aviation Heritage section of the new Farnborough Business Park. Once the library is established, it is the Royal Aeronautical Society's intent to link it electronically to other aerospace collections, both in the UK and abroad, so offering a comprehensive portal to enthusiasts, researchers and scholars.

When?

All the at-risk material has now been removed from the basement of 4 Hamilton Place and placed, with recently acquired historic material from the CAA and SBAC, in accessible storage at Farnborough. Later this year, the nucleus of the National Aerospace Library will be formally established at 4 Hamilton Place. Work is already underway to restore the wind-tunnel building exterior. A working group has been formed to co-ordinate fund-raising and oversee the project itself. The RAeS would like to establish the NAL by the end of 2008 to coincide with the centenary of the first powered flight in Britain.
